TOWN OF PERTH

Regular Town Board Meeting October 3, 2019 6:00 p.m.

<u>PRESENT:</u> Supervisor Fagan, Councilman Korona, Councilman Lewandowski, and Councilman Betz.

ALSO PRESENT: Town Clerk, Judith English; Budget Officer, Patricia Herba; Town Attorney, Carmel Greco Esq.; Dog Control Officer, Joseph Passino; Employees of the Town of Perth Highway Department; Dan Austro, Richard Wallace, and Kurt Opalka; Tax Collector, Ann Morck; President of Perth Volunteer Fire Department, Katherine Tylutki; James Carney; Rachel, Ethan, and William Waufle.

Supervisor Fagan opened the Meeting at 6:00 p.m. A salute to the flag was held and a moment of silent prayer observed. Supervisor Fagan asked those present to keep Highway Superintendent David Dopp's family in their thoughts following the recent death of his father.

APPROVAL OF MINUTES

The minutes from the Town Board Meeting held on September 5, 2019 were offered for approval by Councilman Lewandowski and seconded by Councilman Korona. All were in favor; motion carried.

PUBLIC HEARING

Supervisor Fagan opened the Public Hearing on Local Law #1-2019 entitled "Opting Out of Section 487 NYS Real Property Tax Law Exemptions for Solar Energy System, Wind Energy System, and Farm Waste Energy System Projects" at 6:05 p.m.

There was no one present to comment either for or against the law. Supervisor Fagan closed the Hearing at 6:41 p.m.

COMMUNICATIONS

The Communications as listed on the Agenda are filed in the Town Clerk's Office where they are available for anyone who wishes to see them.

UPDATE FROM STANDING COMMITTEES

Councilman Korona reported for **Buildings** that he would like to thank the Town of Perth Highway Department for the retaining wall that was erected on the west side of the Town Hall Complex, and cleaning up the area around the creek. They will fill the planters on the top of the wall in the spring, and flowers will be planted. **Budget Officer, Patricia Herba**, reported that she has called Magielda Construction to order topsoil for this purpose.

Supervisor Fagan asked when paving of the Town Hall Complex driveways and parking areas will begin. **Highway Employee, Dan Austro**, stated that paving will be in the middle of October. The Highway Department will call BTU Heating and Cooling to move the air conditioners before paving begins.

Councilman Betz read the **Assessor's** Report, a copy of which will be filed with these minutes where it is available for anyone who wishes to see it. The Assessor attended the NYS Assessor's Association Annual Fall Conference for four days. The Classes he took were excellent, and he received 12 hours of Continuing Education Credit.

Councilman Lewandowski read the **Dog Control Officer's** Report, a copy of which will be filed with these minutes where it is available for anyone who wishes to see it. There were a total of five complaints, one impound, three dogs at large and one dog bite.

Town Attorney, Carmel Greco Esq., reported that he has Town of Perth Local Law #1-2019 entitled "Opting Out of Section 487 NYS Real Property Tax Law Exemption for Solar Energy System, Wind Energy System and Farm Waste Energy System Projects" ready for approval.

Supervisor Fagan reported for the Highway Department that everything is going fine. The shoulders are done on the newly paved roads.

He also reported that the County is continuing to work on the 2020 Budget.

Each Town Board member received a copy of the Town of Perth Tentative Budget for 2020. **Supervisor Fagan** suggested October 21, 2019 at 6:30 p.m. for a Budget Workshop at which time the Board will go over it line for line.

OLD BUSINESS

There is still water on the floor in the Records Room, and outside of the room in the cellar. Mold is starting to form on the concrete and as of this date nothing has been done to correct the situation.

PUBLIC SPEAKERS

Jim Carney of Watrobski Drive came to the meeting to discuss if anything could be done about an abandoned property near his to clean up the area. The person who owned the home died a while ago, and the relatives are not interested in the home. Consequently the grass has grown to about three feet high. The bushes and the trees are not trimmed, and weeds are everywhere. He feels that the situation is decreasing the market value of his property, and he would like the Town to do something about it.

He has filed a formal complaint with Town of Perth Code Enforcement Officer, Mark Concilla. He gave him a copy of a law from the Village of Hagaman that addresses the question of property maintenance. He stated that Supervisor Fagan and Councilman Betz had been out to his home to inspect what he was complaining about. He feels that the situation will invite rats and vandalism to the area.

Town Attorney, Carmel Greco Esq., told him that for the Town to go on the property to clean it up would amount to trespass. He has reservations about the Village of Hagaman Law, if it is even Constitutional. He stated that he would look into it further to see if there is any remedy available to the Town to use to clean up the property. He questioned whether the Health Officer could investigate if rats are being seen on the property.

EXECUTIVE SESSION

At 6:30 p.m. Supervisor Fagan called for the Town Board to go into Executive Session for Collective Bargaining discussion. It was offered by Councilman Korona and seconded by Councilman Betz; all were in favor: Motion carried.

At 6:40 p.m. a motion was made by Councilman Korona and seconded by Councilman Betz to return to the Regular Town Board Meeting and end the Executive Session. All were in favor; Motion carried.
